SYARIAH COURTS (COURT FEES AND COSTS) RULES, 2005

In exercise of the power conferred by subsection (1) of section 236 of the Syariah Courts Civil Procedure Order, 2005, the Chief Syar'ie Judge hereby makes the following Rules —

**Citation and commencement.**

1. These Rules may be cited as Syariah Courts (Court Fees and Costs) Rules, 2005 and shall commence on the same date as the Syariah Courts Civil Procedure Order, 2005.

**Application.**

2. These Rules shall apply to any proceedings begun in a Syariah Court on or after the date of commencement of these Rules.

**Court fees and costs.**

3. The court fees and costs set out in the Schedule shall be payable in all proceedings in a Syariah Court.

COURT FEES

CIVIL MATTERS

1. On filing a summons, statement of claim, application or counter-claim for a liquidated sum —
  - (a) if the sum does not exceed \$1,000 \$80
  - (b) if the sum is \$1,000 or more but does not exceed \$5,000 \$120
  - (c) if the sum is for \$5,000 or more \$200
2. On filing a summons, statement of claim, application or counter-claim where the value of the subject matter is not ascertainable before the action \$120
